7) Every person in charge of place should be display and exhibit a board stating that the place is a "No Smoking and No Spitting place" and that Smoking or Spitting is an offence"

8) This Certificate issued is liable to be cancelled at any time on infringement if any of the above said conditions and for improper maintenance of sanitation, improper maintenance of the building as well as toilets in the institute.

9) This Sanitary Certificate valid one year only from the date of issue.

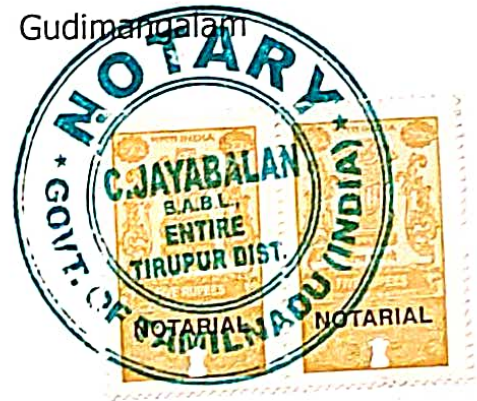
